1. Foreword - General Information for Users

1.1. - Indicazioni Generali agli Utenti

This document sets-forth the Terms of Use (hereinafter also the "**TOU**") for the website <https://lanadestate.baruffa.com> (hereinafter the "**Site**") and lays-down an overview of “netiquette” and intellectual property rights relevant to Contents posted on the Site and/or accessible by browsing it. **N.B.** By accessing to the Site, the User unconditionally accepts to abide-by the TOU and confirms full adherence to the relevant rules, thus we invite you to read the TOU before browsing.

1.2. – Site Development - Cooperation between ZBLB and The Woolmark Company

The Site is the result of a “joint marketing program” with The Woolmark Company (hereinafter referred to as "**TWC**"), owner of the "Pure Virgin Wool" brand (posted on the Site) and international promoter of wool products, sector in which ZBLB stands-out for producing high quality carded and combed yarns. On the foregoing, you may find on the Site:

- the link to the TWC’s “contact-page” (www.woolmark.com/subscribe/) placed at the bottom of the Site-homepage (just under ZBLB’s subscription area).

Please note that the web-site www.woolmark.com, and any of its pages, is not managed by ZBLB, which therefore does not take care of the information, contents and updates published therein.

2. Title on the Site - Content Editing

The Site is wholly owned by **Zegna Baruffa Lane Borgosesia S.p.A.** (Italian joint-stock company - hereinafter also "**ZBLB**"), F.C. 01497250132, VAT. n. 01734930025, with registered office at 13835 Valdilana (Biella - Italy), Via B. Sella n. 140 and operative seat at 13856 Vigliano Biellese (Biella - Italy), Via Milano 160. ZBLB takes care to post/upload/update the Contents as well as to design promotional campaigns as agreed with TWC. At the scope, ZBLB avails of the cooperation of their staff and the technical support of a web-agency.

3. Site Layout

Users can also go to for ZBLB for information through the "registration form", as well as access to TWC's web-site by clicking a referral link to their subscription area (cf. www.woolmark.com/subscribe). The Site does not provide for an e-commerce.

4. Access to the Site

Access to the Site takes place by typing the URL <https://lanadestate.baruffa.com> (or other URLs referring to single Site pages) into the search-string of the browser or by clicking on search-engine results belonging to the Site. The User must be provided with IT devices (e.g. PCs, tablets, smartphones) linked to Internet, for which it shall be his/her responsibility to get suitable equipment, hardware, software, operating systems, network subscriptions, Internet browsers and anything else necessary to browse the Site and its Contents.

N.B. ZBLB may, on the basis of its own needs or for technical reasons, suspend or terminate access to the Site, to part of the Contents or to certain services without prior notice and without any liability arising therefrom (cf. also Article 8).
